

WSOC-FM Walt Disney World Trip Contest Rules

These rules apply to the Walt Disney World Trip Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WSOC-FM (“Station”). **In addition, the General Contest Rules posted at www.country1037fm.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Monday, March 20, 2023 and end on Sunday, April 30, 2023.
- b. To enter online, visit www.country1037fm.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on March, 20 2023 at 12:00am Eastern Time (“ET”) and ending at 11:59pm ET on April 30, 2023 (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person per day during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of one (1) winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to one (1) Grand Prize will be awarded. The Grand Prize is being provided by Disney and consists of one (1) vacation package(s) for four (4) persons for three (3) nights and four (4) days at the Walt Disney World® Resort. Vacation package ("Vacation") shall consist of the following:
 - a. Four (4) round trip coach airfares between the major gateway airport closest to traveler's residence and the Orlando International Airport.
 - b. One (1) round trip ground transfers between the Orlando International Airport and the Walt Disney World® Resort via limousine or SUV.

- c. Room accommodations consisting of one (1) standard room(s) (with a maximum of four (4) persons per room) for three (3) night(s) at a hotel at the Walt Disney World® Resort selected by Disney in its sole discretion; based on availability.
 - d. Four (4) 4-Day Theme Tickets with Park Hopper® Option.
 - e. One (1) Disney Gift Card valued at \$300.
- b. NOTE: Items that are not included as part of the winning vacation package(s) are: meals, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, etc., local and long distance telephone calls, tips, gratuities, service charges or taxes. All other charges and items not otherwise described above.
- c. The estimated retail value of the vacation package is US \$7,133.28.**
- d. Winning vacation rules include, but are not limited to:
- Vacation must be taken between 3/15/2023 and 4/30/2024.
 - Departure date and accommodations are subject to availability; certain restrictions and block-out dates may apply.
 - Vacation is for the winner(s) of the sweepstakes/contest and up to three (3) guests of the winner's choosing.
 - Vacation and vacation components may not be sold, traded, transferred, rescheduled to dates not within the fulfillment period set forth above, or refunded. Vacation(s) is/are not redeemable for cash.
 - The actual value of the Vacation may vary depending on point of departure and fluctuations of rates and airfares (if applicable). If the actual value of the Vacation is less than stated estimated retail value, the difference will not be awarded.
 - Theme parks, attractions and other offerings are subject to availability, closures, change or cancellation without notice or liability. Park admission, offerings and ticket options are not guaranteed.
 - To visit the theme parks, theme park reservations via the Disney Park Pass system (<https://disneyworld.disney.go.com/experience-updates/park-reservations/>) AND valid admission are required for the same theme park on the same date for each person in the group ages 3 and up. Reservations are subject to availability and are not guaranteed until a reservation is finalized. A park reservation must be made for each day of entry.
 - An inherent risk of exposure to COVID-19 exists in any public place where people are present. By accepting and using the Vacation and visiting the Walt Disney World® Resort, the winner and guests voluntarily assume all risks related in any way to exposure to COVID-19, and any other communicable or infectious disease. The winner and guests must comply with all theme park rules and regulations, including any public health restrictions. Failure to do so may result in forfeiture of such portion(s) of the prize. Disney reserves the right to remove or deny entry to the winner and/or any of the guests who do not comply with any health restrictions imposed by any government, or Disney.

The winner and guests are also responsible for understanding and complying with any COVID-19 travel restrictions. Before visiting, each guest should visit <https://disneyworld.disney.go.com/experience-updates/> to view important information about park reservations, limitations on benefits, features, experiences and offerings, safety measures and other information.

- The winner and guests will be required to execute a liability/publicity/COVID-19 release and waiver form prior to booking of any travel. The winner and guest may be required to execute and return, where legal, publicity releases, which must be returned with the verification documents requested of winner.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner's stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. In addition, winner and guest(s) should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before, during and after the trip. **Prize winner will receive from the Station an IRS Form 1099 (or similar) in the amount of the Prize for the 2023 tax year.**

- e. All prizes or prize certificates must be claimed as directed by the Station at the time of notification. Prize or prize certificate must be claimed within forty-eight (48) hours of winning. Failure to claim prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to one (1) Prize winner will be selected at approximately 10:00am ET on Monday, May 1, 2023 in a Station-conducted random drawing from all eligible online entries received during the Online Entry Period. Potential Prize winner will be notified by phone and/or email promptly following the random drawing.
- b. Odds of winning depend on the number of eligible online entries received during the Online Entry Period.
- c. Entrants need not listen to the Station or be present to win.
- d. Winner must confirm acceptance of prize within forty-eight (48) hours of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible entries.
- e. Decisions of Station management with respect to the Contest are final.
