Jamaica Trip Online Giveaway OFFICIAL CONTEST RULES

These rules apply to the **Jamaica Trip Giveaway** Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WSOC-FM (“Station”). **In addition, the General Contest Rules posted at country1037fm.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on January 30, 2023 and end on February 26, 2023.
- b. To enter online, visit country1037fm.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on January 30, 2023 at 12:00am Eastern Time (“ET”) and ending on February 26, 2023 at 11:59pm ET (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person per day during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of two (2) winners selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

- a. Up to two (2) prizes will be awarded. Each prize is a four-day/three-night Luxury Included® Vacation for two (2) adults to any of the sixteen (16) Sandals Resorts listed below, with locations in Jamaica, Antigua, Saint Lucia, The Bahamas, Barbados, Jamaica and Curacao and round-trip coach airfare tickets for two (2) adults through American Airlines to the destination (“Sandals Prize Package”). Accommodations are valid for one (1) room double occupancy, king size bed deluxe room, all meals, unlimited premium brand liquors, daily & nightly entertainment, an array of land and water sports activities, including daily scuba diving (for certified divers), snorkeling, Wi-Fi in all rooms and public areas, resort taxes, resort gratuities, and Sandals Resorts transfers to and from the resort’s designated airport.

Round-trip coach airfare for two (2) adults valid to/from the nearest major U.S. gateway of the prize winner to the selected or designated resort’s airport.
