

## **2024 Fantasy Concert Flyaway Summer- HARDY Official Contest Rules**

These rules apply to the “Fantasy Concert Flyaway Summer Hardy” Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WSOC-FM (“Station”). In addition, the General Contest Rules posted at [www.country1037fm.com](http://www.country1037fm.com) apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.

### **1. HOW TO ENTER**

- a. The Contest will begin on Thursday, June 6, 2024 and end on Friday, June 14, 2024.
- b. To enter, visit [www.country1037fm.com](http://www.country1037fm.com) daily beginning on Thursday, June 6, 2024 and ending on Friday, June 14, 2024 at approximately 12:00am Eastern Time (“ET”) for the Station’s announcement of what times the three (3) cues to call air will air later that same weekday. Each weekday will have up to three (3) cues to call. Then, entrants must listen to the Station at the designated times for the announcement of the cues to call. Upon hearing the cue to call, the designated number caller (as announced on-air at the time of the cue to call) to the Station contest line at 704-570-1037 win a Qualifying Prize and be qualified for a chance to win the Grand Prize (each deemed a “Qualifier”) upon confirmation of eligibility. Station is not responsible for any failure of a caller to reach the Station contest line including but not limited to busy phone lines, misdirected calls, equipment breakdowns, or disconnections. Calls will only be accepted at the designated phone number. At the time of entrant’s call, entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected, or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line, and completes the call will be a Qualifier. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a Qualifier only once.
- c. There will be up to a total of twenty one (21) Qualifying Prize winners and one (1) Grand Prize winner selected in the Contest.

### **2. ELIGIBILITY RESTRICTIONS**

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

### 3. PRIZES

- a. Up to twenty one (21) Qualifying Prizes will be awarded. Each Qualifying Prize consists of two (2) tickets to see Hardy at PNC Music Pavilion on Friday, June 14, 2024. The Approximate Retail Value (“ARV”) of each Qualifying Prize is \$170.

The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize(s) is awarded as is. Tickets valid only on the date(s) printed on the tickets. Tickets are not refundable or transferable, and may not be substituted or exchanged for cash or credit at any time, nor will tickets be replaced if lost or stolen. Tickets may not be sold to a third party. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond control of the Station and/or prize provider, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded element(s) of the prize(s). The Station and/or venue, in their sole discretion, reserve the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior, does not follow Station and/or venue policy regarding COVID-19 guidelines, or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize-related event. Winner understands that there are inherent risks involved in attending the prize-related event.

- b. Up to one (1) Grand Prize will be awarded. The Grand Prize is a trip for two (2) (winner and one (1) guest) to Milwaukee, WI to see HARDY. The trip includes roundtrip airfare for two (2) from a Charlotte, NC area airport to a Milwaukee, WI area airport departing on Friday, July 26, 2024 and returning on Sunday, July 28, 2024, two (2) nights standard hotel accommodations for two (2) at the Saint Kate Hotel checking in on Friday, July 26, 2024 and checking out on Sunday, July 28, 2024, and two (2) tickets to see HARDY at the Harley Davidson Homecoming Festival on July 26, 2024. Trip dates are Friday, July 26, 2024-Sunday, July 28, 2024. ARV of the Grand Prize is \$2,345.

Actual value may vary and any difference between stated value and actual value will not be awarded. Certain travel restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and additional ground transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. Selection of airline, hotel, and airline seat location at sole discretion of Station and/or prize provider. Airline regulations apply. The winner and guest must travel on the same itinerary and are responsible for obtaining all required travel documents, including, without limitation, passports for international travel. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner’s stay. Winner and guest must abide by all airline, hotel, and venue policies. The winner and

guest must sign all required releases prior to booking of any travel. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station's sole discretion. All travel is subject to availability and restrictions. If a prize-related event or travel is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any flight. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. In addition, winner and guest(s) should be aware of and comply with government guidelines regarding travel restrictions and mandatory quarantines before, during and after the trip. **Winner will be issued a 1099 for 2024.**

- c. Prizes or prize certificates must be claimed at the office of the Station located at 1520 South Blvd, Suite 300, Charlotte, NC 28203, Monday-Friday, during regular business hours. Prize or prize certificate must be claimed within five (5) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner's sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

#### **4. SELECTION OF WINNERS**

- a. Up to twenty one (21) Qualifiers will be selected and notified on-air as described above.
- b. Up to one (1) Grand Prize winner will be selected at approximately 9:00am ET on Monday, June 17, 2024 in a Station-conducted random drawing from all Qualifiers. Potential Grand Prize winner will be notified by phone and/or email promptly following the random drawing.
- c. Odds of winning a Qualifying Prize on-air depend upon the number and order of calls received. Odds of a Qualifying Prize winner winning the Grand Prize are up to 1 in 21.
- d. Entrants must listen to the Station to win a Qualifying Prize but do not need to be present to enter or win a Qualifying Prize. The Qualifying Prize winners do not need to listen to the Station or be present to win the Grand Prize.
- e. Grand Prize winner must confirm acceptance of prize within five (5) days of winning,

or risk disqualification and selection of an alternate Grand Prize winner (time permitting) in a random drawing of all remaining Qualifiers.

- f. Decisions of Station management with respect to the Contest are final.
