

Sandals Curacao Trip Online Giveaway OFFICIAL CONTEST RULES

These rules apply to the **Sandals Curacao Trip Giveaway Contest** (“Contest”) conducted by Beasley Media Group, LLC d/b/a WSOC-FM (“Station”). **In addition, the General Contest Rules posted at www.k1047.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Saturday, September 14, 2024 and end on Sunday, October 13, 2024.
- b. To enter online, visit www.country1037fm.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on September 14, 2024 at 12:00am Eastern Time (“ET”) and ending on October 13, 2024 at 11:59pm ET (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person per day during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of two (2) winners selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to two (2) prizes will be awarded. Each prize is a four-day/three-night All Inclusive Vacation for two (2) adults to any of the ten (10) Sandals Resorts listed below, with locations in Jamaica, Curacao, The Bahamas, and St. Vincent and The Grenadines and round-trip coach airfare tickets for two (2) adults through American Airlines to the destination (“Sandals Prize Package”). Approximate Retail Value of each prize is \$3,994.

The Sandals Prize Package is subject to availability and certain blackout dates including but not limited to all major US holidays.

The Sandals Prize Package will be issued in the form of a prize certificate (the "Prize Certificate") outlining the terms and conditions of the Sandals Resorts Prize Package and redemption procedures.

Sandals Resorts is an All-Inclusive romantic, adults-only resort destination exclusively for couples only. The Sandals Prize Package recipient and travel companion must be 18 years of age or older.

The Sandals Prize Package must be redeemed for travel within one (1) year from the Prize Certificate is issued ("Sandals Prize Package Redemption Period") and is not transferable or redeemable for cash. The Sandals Prize Package must be redeemed for travel during the Sandals Prize Package Redemption Period and is not transferable or redeemable for cash. No extension will be given after the Redemption Period has expired. If the Prize is not redeemed, the Prize will be forfeited. Reservations will not be confirmed until 30 days prior to the selected travel date.

SUBSTITUTION OF RESORT. The accommodations portion of the Sandals Prize Package is subject to space availability and selected blackout dates. Unique Travel Corp, the worldwide representative for Sandals Resorts (the “Sandals Prize Package Provider”) and Sandals Resorts each reserves the right to relocate any confirmed prizewinner from the selected resort to an alternate resort within the resort’s chain and to change dates with prior notice should circumstances so require or for any circumstance(s) beyond the resort’s control.
